

## INFORMATION ON THE PROCESSING OF PERSONAL DATA

Dear Supplier,

FOREL SPA, Via per Monastier 4, Vallio di Roncade - 31056 (TV), as owner of the processing of your personal data (hereinafter the "Data Controller"), issues this information notice to the Data Subject in accordance with the European and Italian regulations on the protection of personal data.

The supplier acknowledges that the provisions of the privacy policy – Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data, hereinafter the "GDPR" – concern the processing of personal data, relating solely to natural persons. For the purposes of managing the business relationship, the Controller processes personal data concerning (i) the Customer, if it is an individual enterprise or self-employed person, and/or however (ii) the representatives, agents, employees or collaborators of the customer's company.

### **Legal basis and purpose of the processing**

The Data Controller processes the Supplier's personal data in order to pursue the legitimate interest in carrying out qualification and/or monitoring procedures regarding it, to adopt pre-contractual measures, to fulfil contractual and regulatory obligations related to the commercial relationship, as well as to manage any litigation.

The legal basis of the processing is the need to pursue the above purposes.

### **Data retention period**

The Data Controller shall process the Supplier's data for the entire duration of the commercial relationship and, subsequently, to fulfil all related or ensuing obligations, for the period of time prescribed by law and in accordance with the period of prescription of the rights arising from the commercial relationship, without prejudice to further retention for the time necessary to settle (however reached) any disputes that may arise.

### **Nature of data provision and consequences of refusal to provide data**

The provision of data is necessary and therefore any refusal to provide them in whole or in part may make it impossible for the Data Controller to pursue the aforementioned purposes.

### **Categories of recipients**

The Data Controller will not disclose the data, but intends to communicate them to internal figures authorised to process them in order to perform their respective tasks, and also to companies of the Group, commercial agents, credit institutions, credit insurance companies, credit recovery companies, commercial information companies, factoring companies, consultants, associations and/or business organisations, professionals or service companies, and public and private bodies, also following inspections and audits.

Should these recipients process data on behalf of the Data Controller, they will be appointed as data processors with a specific contract or other legal document.

### **Transfer of data to a third country and/or international organisation**

Personal data will not be transferred to any third countries outside Europe, or to international organisations.

### **Rights of Data Subjects**

Data subjects shall have the right to ask the Data Controller to access their personal data and to rectify any inaccuracies, to erase them or limit their processing if the conditions are met, to object to their processing for legitimate interests pursued by the Data Controller, as well as obtain the portability of personal data only if they have been processed by automated means based on consent or on a contract. Data Subjects also have the right to withdraw the consent given for the processing purposes that require it, without this affecting the lawfulness of the processing carried out until the moment of withdrawal.
